The Diamond Peak Ski Education Foundation is proud to announce its **10th Annual Diamond Cup Challenge**. Race categories for this popular event include Individuals (age/sex groups), Family, Husband/Wife, Father/Son, Father/Daughter, Mother/Son, Mother/Daughter, Corporate Teams (of four), and Snowboard Individuals. Grandparents are also invited. The race will be a dual giant slalom format on Lower Show- Off at Diamond Peak. We will begin at 1:00 p.m. Race start order will be based on bib number, lowest to highest and will be dependent on order of registration, so EARLIEST REGISTRATION, LOWEST BIB NUMBER, EARLIEST START (or first come, first served!). If you wish to start at the same time as a family member or friend - we can only guarantee it if you both are on the same Registration sheet!

The entry fee is \$20 per racer if received by Thursday, March 17th; \$25 after that date. **Race day registration will be from Noon at the Diamond Peak Lodge.** The entry includes two runs on the “friendly” dual giant slalom course, a BBQ , and Awards Ceremony held after the race. Awards will be given to the top three competitors in each race category. BBQ tickets for non-racers are also available for \$10. Proceeds from this fun event benefit the Diamond Peak Ski Team.

Each racer must have a lift ticket or Diamond Peak season pass to participate: **All racers are required to complete a Liability Release form prior to competing.** If necessary, please make copies of the Liability Release for each racer in your group. Liability Release is page 2 of this form.

The inherent risks of skiing and ski racing are hereby defined, but not limited to these definitions, as those dangers of conditions which are an integral part of the sport of skiing, whether natural, man-made, or man modified – including, but not limited to, changing weather conditions, variation or steepness of terrain and race course design, snow ice conditions, surface or subsurface conditions, rocks, spots, creeks, gullies, forest growth or rocks, stumps, lift towers and other structures and their components, collisions with other skiers and racers, collisions with other obstacles and racing gates, and a skier's or racer's failure to ski within the skier's own ability. Such inherent risks can result in personal bodily injury, including death and/or property damage.
